

# **Product Warranty Notice**

# **Conditions:**

Summary of Warranty Terms (full details of warranty on page two)

1. Coverage:

Products are covered by a 12-month parts-only warranty from purchase, for both domestic and commercial use, unless otherwise specified.

2. Claim Process:

If defective, the product must be returned (at the purchaser's expense) to an Arrow Sales Trade Centre. Replacement parts are issued after inspection and verification of the defect.

3. Exclusions:

Warranty does not cover damage from misuse, neglect, improper installation, shipping accidents, voltage issues, unauthorised repairs, corrosive/weather exposure, or if no defect is found.

4. Liability Limit:

Liability is limited to replacement of the product or supply of an equivalent. No liability for other losses or damages.

5. Additional Exclusions:

Does not cover third-party goods, damage to property other than the product itself, consequential losses, or labour costs. Warranty is strictly limited to product replacement, with no further compensation.

Variations to the standard 12 month PARTS ONLY warranty are noted below:

# **Product Warranty Notice**

### 1. Warranty Coverage

All products sold under the Arrow Sales - TRADESTORE Accessories range ("the Products") are warranted for a period of twelve (12) months from the date of purchase.

This warranty is limited to the replacement of parts only and applies to both domestic and commercial installations, unless expressly stated otherwise in the accompanying tables or documentation.

## 2. Warranty Claim Process

In the event of a defect in a Product, the Purchaser must return the defective Product at their own expense to an Arrow Sales Trade Centre prior to the issuance of a replacement part.

Arrow Sales - TRADESTORE reserves the right to inspect the returned Product to verify the defect. Replacement will be provided for defective parts only, subject to the terms herein.

### 3. Warranty Exclusions

The warranty set forth herein shall not apply to, and Arrow Sales - TRADESTORE shall not be liable for, any damage or defect resulting from:

- Misapplication, misuse, neglect, or abuse of the Product;
- Shipping accidents or improper handling;
- Incorrect or improper installation;
- Issues arising from voltage supply or power quality;
- Unauthorised modification or repairs;
- Exposure to corrosive conditions or adverse weather;
- Any instance where no defect is identified in the Product upon inspection.

#### 4. Limitation of Liability

Arrow Sales - TRADESTORE's liability for any defect arising from design, materials, or workmanship shall be strictly limited to, at its sole discretion,

the replacement of the Product or the supply of an equivalent product. Except as expressly provided herein,

Arrow Sales - TRADESTORE shall not be liable for any other loss or damage, whether direct, indirect, incidental, or consequential.

### 5. Additional Exclusions to Warranty

The warranty shall not cover:

- Third Party Goods;
- Damage to furniture, carpets, walls, ceilings, foundations, vehicles, or any other property or item not forming part of the Product itself;
- Any consequential loss, whether direct or indirect, arising from the malfunction of the Product;
- Labour costs associated with removal, installation, or servicing of the Product.

Subject to any statutory provisions to the contrary, the warranty is strictly limited to the resupply of the defective Product and does not extend to any additional compensation, damages, or costs.
